

BCBS MI 2020 Medicare Certification Instructions

- 1. Go to the BCBS MI certification site here.
- 2. Select "Click here to register" at the top right.
- 3. Check the box labeled "I only have an access code."
- 4. Input NewAgent2020 as the access code.

- 5. Click "Continue."
- 6. Click "Lookup NPN using NIPR" and follow the prompts to locate your NPN.
- 7. Click "Submit."
- 8. Input your BCBS MI writing number as the Agent Code.
- 9. Select 57 as the MA/GA code.
- 10. Select "Individual MA Michigan" only; do not select "Group MA Michigan."
- 11. Input a password and security question.
- 12. Click "Register" and then "Continue."
- 13. Once logged in, click on the "Certifications" box.
- 14. Utilize the dropdown menu next to "Annual Requirement Year" to alternate between 2019 and 2020 certification year requirements.
 - a. Complete the 2019 Medicare Advantage and Medicare Supplement Training Module in order to be able to market 2019 plans.
 - b. Complete the 2020 Medicare Advantage and Medicare Supplement Training Module in order to be able to market 2020 plans. Completion of the 2020 certification does <u>not</u> allow agents to market 2019 plans.

- 15. Once certification is complete:
 - a. The "My Transcripts" page will show if all requirements have been fulfilled.
 - b. Within a couple of business days, you will receive an email from BCBS MI confirming your certification status along with a username and password for accessing the BCBS MI enrollment tool, DRX.
 - c. Until this written confirmation has been received, an agent should not market or sell BCBS MI Medicare products. Doing so will result in the agent being out of compliance.
